"Class C" Wine License for Restaurants.....	100.00

A restaurant's sale of wine must be less than 50% of gross receipts. If there is a barroom, wine must be the only intoxicating liquor sold.

Reserve "Class B" Liquor License .....	10,000.00

Original Reserve "Class B" liquor licenses can be issued after all regular "Class B" liquor licenses have been issued. (The \$10,000 initial issuance fee is for each initial issuance to a new licensee. If a current licensee is a corporation and the corporation is sold, then the corporation would not have to pay the initial issuance fee again.) The regular license fee must be paid in addition to the \$10,000.

Except for Reserve "Class B" liquor, may transfer once a year.

**Individuals/Partners/Agents** (of an LLC or Incorporation) named on original liquor license application must:

- **Take a Responsible Beverage Servers Course** approved from the State of Wisconsin;
- **Have fingerprints taken** by the Police Department before license issuance; and
- **Have a background check** done by the Police Department.

**Fingerprinting Days & Times:** Tuesdays from 6 am – 2 pm & Wednesdays from 2 pm – 10 pm.

All new license applications **must be filed a minimum of 15 days** prior to action by the Council, and both new applications and renewals require a Class I legal publication in the official newspaper and approval by the Common Council.

Operator (Bartender) License \$30.00 Plus a \$20.00 Background Check Fee .....	50.00

Applicants must be at least 18 years of age, employed by a licensed establishment in the City and show proof of completion of an approved Wisconsin Responsible Beverage Servers Course or holding an operator's license in another community within the State within the previous 2 years. An operator's license requires a background check by the Police Department and will be issued by the Clerk's office upon approval of the background check.

Forms for operator (bartender) license renewal must be filed with the City Clerk's office **no later than May 26, 2023.**

**Provisional Operator (Bartender) License \$15 Plus \$20 Background Check & \$20 Regular License ... 55.00**

A provisional operator's license allows an individual to bartend without another licensed bartender in direct supervision and is valid for up to 60 days **or upon completion of a background check by the Police Department.** To qualify an applicant must provide a certified copy of a current license from another community or proof of enrollment in or completion of an approved Wisconsin Responsible Beverage Servers Course, and a written statement by a sponsor who must have an alcohol license stating the length of time the sponsor has known the applicant, that the applicant has a place of employment and that the sponsor shall reimburse the City for any expenses incurred by the City in revoking the applicant's provisional operator's license.

**Special Class "B" (Picnic) Licenses ..... 10.00**

This license is available for special events for non-profit organizations to sell beer and/or wine. The fee is \$10.00 whether selling only beer, only wine, or both. The \$10.00 fee is calculated **per event** (not per day). Organizations may obtain only 2 permits per year for wine.

**Cigarette and Tobacco Products ..... 100.00**

**Juke Box and Amusement Devices (that do not pay out) ..... 25.00 per device**

**Amusement Device Operator/Distributor License ..... 150.00**

Requires approval by Common Council.

**Theatre..... 75.00**

**Peddler/Solicitor Permit \$100 / Plus a \$20.00 Background Check Fee for each Solicitor..... 120.00 Minimum**

Each peddler/solicitor must complete an application, provide a copy of their Driver's License, and have a background check done by the Police Department. **Up to 3** individuals may solicit per permit which is good for 1 year from issuance. The process may take up to 72 hours to complete, and the Clerk's office will issue the permit upon approval of the background check.

**Secondhand Article Dealer Mall or Flea Market..... 165.00**

Requires approval by Common Council.

**Secondhand Article/Jeweler \$40/ Plus a \$20.00 Background Check Fee ..... 60.00**

Requires approval by Common Council.

**Pawnbroker \$500 Sureties Bond ..... 210.00**

Renew yearly.

**Arcade License ..... 150.00 + 25.00 per device**

This license is required for establishments with **3 or more** amusement devices and requires Council approval. Please note that an arcade license is not required for alcohol-licensed establishments. The arcade license procedure requires a premise inspection by the Building Inspector and Police Department. In addition, a \$25 fee for each device is also required.

**Passenger Transportation Vehicle / Driver (Taxi / Quadricycle)**

First vehicle ..... **25.00**

Each additional vehicle ..... **5.00**

Driver \$5.00 / Plus a \$20.00 Background Check Fee ..... **25.00**

A Certificate of Insurance is required with the license application. The vehicle owner must schedule safety inspections of the car(s) / quadricycle(s) with and be approved by the Police Department. Vehicle & driver applications require Police Department and Common Council approval.
